# APPROVING GMP AMENDMENT NO. 1 TO THE CMR AGREEMENT WITH SIMONSON-REGENCY CONSTRUCTION SERVICES, LLC FOR THE NEW PK-12 BUILDING PROJECT AND AUTHORIZING EXECUTION OF THE AMENDMENT
