B. Report – Ashland County – West Holmes Career Center

Mr. Schuck informed the Board that the renovation project costs at the Career Center are coming in higher than budgeted. The State mandated that a turn lane be put in on State Route 60 at a cost of \$2 million. ACWHCC is wanting the State to help with this cost. Current enrollment for the Career Center is 532 High School students, and 45 Adult Education students. This is the highest number of high school students ever enrolled.
