5. Traditional In-Person Model: 100\% of students and staff would return to school buildings with daily attendance. All students would be provided education in a typical classroom with safety protocols followed. However, social distancing would not be enforceable. Some typical activities could be eliminated to ensure safety procedures are in place.

5b. Blended Learning Model: Students would attend school in the buildings for two to three days per week, receiving instruction in the classroom with a smaller group of students. On the days not in attendance in the buildings, students would complete online or packet work to reinforce the learning done in class during those two to three days in class. During building attendance, students and staff would be expected to follow restrictions per public health guidelines (social distancing, wearing masks, etc.). The school would provide support to students and parents using online tools. 381 responses


5c. Full Online Model: Students would not return to the buildings but would receive all instruction using online platforms, such as video, email, Google Classroom, Google Hangouts and/or Zoom. Teachers would provide instruction remotely from their classrooms using these platforms and work with students, both in whole groups and individually. Student work would be turned in digitally and/or through completed packets. The school would provide support to students and parents using online tools.
